Departmental reports were reviewed.

The responsibility of grass violations was discussed. Currently the DPW submits a list to the Code Enforcement Officer who proceeds to send a notice of violation. It was agreed that the Code Enforcement Officer should address the property maintenance violations from beginning to end as the DPW does not have the time to locate the violations.

There was a discussion on grease traps in local restaurants. Code Enforcement Officer Michael Salvatore informed the Board that the installation of grease traps is not mandatory in all instances. He explained the difference between "brown grease" and "floatable" grease. "Brown grease" which is liquid when hot but becomes solid when cooled would come from animal fat i.e. bacon, burgers, etc. This is the type of grease that can cause problems in the sewer lines. "Floatable grease" floats on the surface of the water and never solidifies, this would be used in deep frying, etc. "Floatable" grease is usually recycled for profit. The need and size of a grease trap is determined by the number of occupants allowed and hours of operation.

A report was not submitted by Fire Chief Richard Knapp. Clerk Falsetta was directed to type another memo reminding him that monthly reports are mandatory. The memo is to be hand delivered to the fire station by a member of the DPW.

A MOTION was made by Deputy Mayor Schoonmaker, seconded by Trustee Caramore, voted and carried to accept all monthly departmental reports.

A letter requesting a zoning change from Industrial to General Business at 593 West Main Street (Tax Map #'s 428.20-7-1 and 428.20-1-7.2) was received from Property owner Russell Bass.
